## KIWANIS, UNICEF JOIN FORCES

*The Eliminate Project will protect mothers and babies from Tetanus*

Kiwanis International and UNICEF have joined forces to save the lives of babies and their mothers by eliminating maternal/neonatal tetanus (MNT), a disease that kills an estimated 60,000 newborns and 30,000 mothers each year. UNICEF Ambassador and actor Tea Leoni delivered the announcement at the 95th Annual Kiwanis International Convention.

“Kiwanis believes that no baby or mother should have to suffer the devastating effects of MNT,” said Kiwanis International President Paul Palazzolo. “Kiwanis will mobilize its nearly 600,000 family members to become tireless advocates for these children and raise needed funds to defeat this deadly disease.”

MNT is easily prevented by a series of three vaccinations to women of childbearing age, costing roughly US\$1.80. The Eliminate Project: Kiwanis eliminating maternal/neonatal tetanus will raise US\$110 million over the next five years to fill the funding gap required to provide an estimated 387 million doses of the vaccine.

The Eliminate Project will deliver life saving vaccines to the most vulnerable women and children in the world: those in remote and difficult to reach areas; conflict zones; and with little access to healthcare.

“With Kiwanis by our side, we will be able to conquer maternal/neonatal tetanus,” said U.S. Fund for UNICEF President and Chief Executive Officer Caryl Stern. “I’ve seen how this disease devastates families. Infants suffer, while mothers are unable to comfort their babies. Kiwanis is providing the final push that will protect vulnerable women and their newborns.”

At our International Convention in Las Vegas our Kiwanis President Paul Palazzolo talked about the book “A Christmas Carol” by Charles Dickens. He told the story of Jacob Marley visiting with Scrooge. So I decided I would reread that portion of the book when Jacob Marley came and visited Ebenezer Scrooge. In one part Marley states, “I wear the chain I forged in life...I made it link by link, and yard by yard.” Scrooge says to Marley “But you were always a good man of business.” “Business!” cried the Ghost, ...”Mankind was my business. The common welfare was my business; charity, mercy, forbearance, and benevolence, were, all, my business. The majority of mothers and newborns dying of MNT live in 40 countries located in Africa, and Southern and East Asia. The disease kills one baby every nine minutes. Its effects are excruciating—tiny newborns suffer repeated, painful convulsions and extreme sensitivity to light and touch.

”As a mother of two children, I have known the great joy of welcoming a new life into this world. I couldn’t imagine watching my child suffer and die from a disease that is as easily preventable as MNT is,” said Tea Leoni. “With this new partnership between Kiwanis and UNICEF, so many lives will be saved.”

Not only will The Eliminate Project protect women and babies from tetanus, the project also will create a path for other services, such as clean water, nutrition and other vaccines, to reach the world’s most vulnerable people.

Partnering with UNICEF, Kiwanis successfully completed its first global campaign for children to virtually eliminate iodine deficiency disorders (IDD), the leading cause of preventable mental impairment. Kiwanis raised and leveraged more than US\$100 million, which helped change lives in 103 nations. The number of households estimated to be consuming iodized salt has jumped from less than 20 percent in 1990 to more than 70 percent, and the effort has been heralded as one of the most successful health initiatives in the world.

**MATERNAL/NEONATAL TETANUS (MNT)**

What is MNT?  
In 40 countries around the world, maternal and neonatal tetanus (MNT) can quickly turn the joy of childbirth into tragedy. MNT kills one baby every nine minutes. Its effects are excruciating — tiny newborns suffer repeated, painful convulsions and extreme sensitivity to light and touch. There is little hope of survival. And tetanus kills mothers too.

Who suffers from MNT?  
MNT is caused when tetanus spores, found in soil everywhere, come into contact with open cuts during childbirth. The disease strikes the poorest of the poor, the geographically hard to reach and those without health care.

Can MNT be stopped?  
Yes! MNT is highly preventable. Just three doses of a 60-cent immunization protect mothers, who then pass on the immunity to their future babies. Together, Kiwanis and UNICEF can stop this disease.

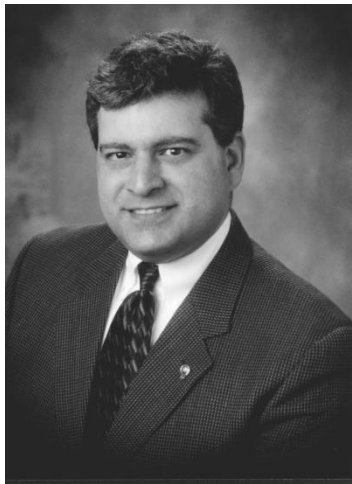

Why hasn't MNT been eliminated already?  
UNICEF has helped to successfully eliminate MNT in many countries. But in 40 countries in Africa, Asia, Europe and North America, it still strikes babies and mothers who have little or no access to health care — either because they are poor, live in remote areas or are caught in humanitarian emergencies. More funds and resources are needed to reach all babies and mothers at risk.

What will it take to eliminate MNT from the Earth by 2015?  
129 million mothers and their future babies must be immunized. This requires vaccines, syringes, safe storage, transportation, thousands of skilled staff and more. It will take \$110 million — and the dedicated work of UNICEF and every member of the Kiwanis family.

Why focus on this issue?  
It is unacceptable that innocent newborns and their mothers suffer and die from MNT when it can be prevented so easily. This is also an amazing opportunity to reach the poorest, most neglected mothers and babies with lifesaving health care. Developing delivery systems for MNT vaccines will blaze a trail to provide additional desperately needed services to these marginalized families.

What is the ELIMINATE partnership?  
Hand in hand, Kiwanis and UNICEF will eliminate MNT and change the world. Kiwanis' commitment, vision and strength in reaching communities and leaders will help wipe out this cruel, centuries-old disease and pave the way for other interventions. UNICEF has staff working in the most isolated corners of the globe and an unbeatable supply chain.

Distinguished Award Criteria  
for 2010-2011

**Distinguished Member.** To qualify, a club member must:

- Sponsor two (2) new members.
- Attend a midyear conference, International convention, or district convention. Equivalent meeting may be Kiwanis University, Zone or Regional Conference, or other district event.
- Participate in two (2) or more Kiwanis service efforts.
- Make a personal contribution to the Kiwanis International Foundation.

The club president will verify those Kiwanians qualifying for Distinguished Member recognition. Distinguished Members will receive a lapel pin and recognition at the 2012 Kiwanis International Convention.

**Distinguished Club.** To qualify, a club must excel in service, leadership education, and growth.

**Service (50 points)**

- The Kiwanis club fulfills its responsibilities to Service Leadership Program club(s) (K-Kids, Builders Club, Key Club, Circle K, Aktion Club, or Kiwanis Junior), which includes providing club leadership education to club officers - *10 points maximum*
- The Kiwanis club builds and charters a new Service Leadership Program club (K-Kids, Builders Club, Key Club, Circle K, Aktion Club, or Kiwanis Junior) - *10 points maximum*
- The Kiwanis club participates in a Kiwanis-branded service project, such as Young Children: Priority One, Read Around the World, Bring Up Grades, Terrific Kids, Key Leader - *10 points maximum*
- The Kiwanis club will initiate one new additional service project during the year– *10 points maximum*
- The Kiwanis club financially supports the Kiwanis International Foundation - *10 points*

**Leadership Education (40 points)**

- The Kiwanis club president and secretary participate in the Club Leadership Education (CLE) training session (or equivalent) prior to assuming office - *20 points (10 points per officer)*
- The Kiwanis Club ensures that all new members receive the Kiwanis International new member orientation - *10 points*
- The Kiwanis club is represented at two of the following three educational opportunities: the district midyear conference (or equivalent of Kiwanis University, zone conference, regional conference), the Kiwanis International convention or the Kiwanis district convention - *10 points maximum*

**Growth (60 points)**

- The Kiwanis club has a net membership gain by the end of the administrative year.  
Maintains current membership- *10 points*  
1-2 members - *20 points*  
3 members - *30 points*  
4 or more members - *40 points*
- The Kiwanis club sponsors (or co-sponsors) a new Kiwanis club - *20 points*

A Kiwanis club that accumulates **50** points by completing all **5 Service** criteria will earn an Outstanding Service banner patch.

A Kiwanis club that accumulates at least **100** points and has properly submitted its Annual Club Report will earn distinguished recognition. The club will receive a Distinguished Club banner patch and a distinguished lapel pin for the president and secretary.

**Distinguished Division.** To qualify, the division must achieve improvement during the period from September 30, 2010 to September 30, 2011 as follows:

- Increase the number of club president and secretaries attending CLE or maintain 100% participation
- Increase or maintain the number of clubs sponsoring Service Leadership Programs
- Increase or maintain the number of Service Leadership Programs

**OR**


To qualify, 80 % of the clubs in the division must have achieved distinguished recognition for the 2010-11 year.

HOUSE APPROVES SEVEN AMENDMENTS

Kiwanis members considered 14 proposed amendments and one resolution during the 2010 Kiwanis International Convention’s House of Delegates. Here’s how they voted:

Adopted:

- **Amendment No. 2:** Eliminate unintended contradictions regarding discipline of International Officers and allow the International Board the ability, if deemed appropriate, to bar someone removed from office from filling other offices or appointments.
- **Amendment No. 4:** Return the title of the top staff position in Kiwanis International to “Executive Director.”
- **Amendment No. 5:** Accommodate districts that wish to have an additional year of training and orientation for the person who eventually will serve as governor.
- **Amendment No. 7:** Make more effective use of electronic methods of communications and information distribution.
- **Amendment No. 8:** Allow federation conventions to be held within the stated 20-day prohibition period for good reason if deemed appropriate by the Kiwanis International Board of Trustees.

Adopted as amended

- **Amendment No. 1:** Change the designation for regions from numbers to names.
- **Amendment No. 3:** Require criminal history background checks for all incumbents and candidates for International Office and for all offices in direct line of succession to district governor in order to ensure the highest standards of leadership in Kiwanis.

Defeated

- **Amendment No. 6:** Allocate the costs to hold Kiwanis International conventions equitably among the member clubs of the organization.
- **Amendment No. 9:** Add a preface clause that summarizes each of the Kiwanis Objects and restate the Objects in summary form.
- **Amendment No. 12:** Allow club members who are not delegates to sit with their club delegates in the House of Delegates at international conventions.

Withdrawn

- **Amendment No. 10:** Allow districts the option to restrict voting at district conventions and division conferences to clubs that are at least one year old, based on the date of charter presentation.
- **Amendment No. 11:** Allow districts the option to determine the number of club delegates (from one to five) based on club size and provide that all delegates must have been club members for at least one year before being elected by the club to represent it.
- **Amendment No. 14:** Create a new class of “family members” providing that up to three relations of an active member may have the same benefits and obligations as active members but pay reduced dues and fees.

Failed for lack of a motion

- **Amendment No. 13:** Reduce dues for members age 65 and over by 50 percent.

Resolution

- Kiwanis delegates approved a memorial resolution to honor Past Kiwanis International President Aubrey Irby, who died July 11, 2009.

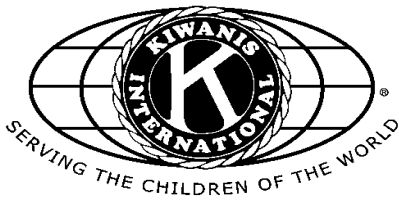

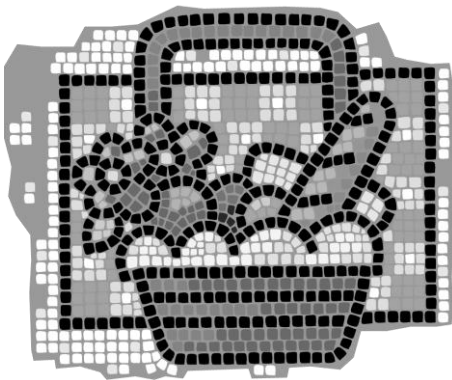

PROPOSED AMENDMENTS TO THE UTAH-IDAHO DISTRICT  
BYLAWS AT THE HOUSE OF DELEGATES AUGUST 28, 2010

AMENDMENT #1

Purpose: To Move Dues Billing to October 1 for All Clubs  
Effective Date: October 1, 2010

Since the District dues are billed and collected by Kiwanis International (thus saving District resources) the District must follow the same system and timing used by Kiwanis International. For that reason, this amendment is housekeeping in nature.

Article XIV. Revenue

**Section 1.** Each member club shall pay to the District for each of its members, with the exception of its honorary members, the sum of \$2.00 per annum as the subscription price of the District bulletin, and \$20.00 per annum as dues. The total amount shall be due annually ~~on the club's anniversary date as set forth in the International Bylaws,~~ **on October 1** payable not later than sixty (60) days thereafter, and is to be based upon the **annual** membership **report** of the respective clubs as shown by the reports to Kiwanis International as of September 30. Such annual membership report shall be due eighty (80) days prior to the due date for the club's annual dues payment and shall be made on the official forms provided by Kiwanis International. The total amount shall include all District charges other than the new member add fee and registration fees for District conventions or conferences.

PROVISO: Between October 1, 2010, and October 1, 2012:

- For clubs organized between September 1 and December 31:
  - o For the year 2010-11, payment shall be based on the club roster as of September 30, 2010, and shall be due October 1, 2010, and payable no later than November 30, 2010.
- For clubs organized between January 1 and April 30:
  - o For the year 2010-11, payment shall be based on the club roster as of Sept. 30, 2010, and shall be due December 1, 2010, and payable no later than January 31, 2011;
  - o For the year 2011-12, payment shall be based on the club roster as of Sept. 30, 2011, and shall be due October 1, 2011, and payable no later than November 30, 2011.
- For clubs organized between May 1 and August 31:
  - o For the year 2010-11, payment shall be based on the club roster as of Sept. 30, 2010, and shall be due February 1, 2011, and payable no later than March 31, 2011;
  - o For the year 2011-12, payment shall be based on the club roster as of Sept. 30, 2011, and shall be due December 1, 2011, and payable no later than January 31, 2012;
  - o For the year 2012-13, payment shall be based on the club roster as of Sept. 30, 2012, and shall be due October 1, 2012, and payable no later than November 30, 2012.

~~**Section 2.** Annual dues payments, as required by Article VI, Section 10, of the International Bylaws shall be due and payable according to the club's organization date as follows:~~

~~Payment for clubs organized between September 1 and December 31, shall be due on December 31<sup>st</sup>.~~

~~Payment for clubs organized between January 1 and April, 30, shall be due on March 15<sup>th</sup>.~~

~~Payment for clubs organized between May 1 and August 31, shall be due on May 31<sup>st</sup>.~~

(The remaining Sections of this Article will be renumbered.)

AMENDMENT TO DISTRICT BYLAWS  
TO MOVE DUES BILLING TO OCTOBER 1<sup>st</sup> FOR ALL CLUBS  
(per Kiwanis International Bylaw Amendment Adopted in 2009 at the  
International Convention in Nashville, TN)

The District Bylaws need to be amended to show when the dues for all clubs in Kiwanis International will be due eventually on October 1<sup>st</sup> and payable no later than November 30<sup>th</sup>.

The effective date of this bylaw amendment is October 1, 2010, not immediately upon adoption at the District Convention in August.


Be aware that the Proviso is a necessary component since it states how Groups 2 and 3 clubs will transition into the new system.

All clubs need to know how and when their dues billing will be sent and when payment will be due.

Invocation by Rayleen Barnes

In attendance: Governor Brent Ashworth, Governor-elect Bob Dempsay, Immediate Past Governor Pattie Hansen, Secretary Janet Flinders, and Treasurer Marvin Chamberlain. Lt. Governors: Div 2 – John Brown; Div 3 – Janet Flinders; Div 4– Jim Terry (Substitute for Joaquin Blanco who has moved to Texas); Div 8 – Rayleen Barnes; and Div 10 – Gene Colledge. Guests: Norman Taylor – Key Club Administrator; Gordon Lewis – U&I Kiwanian Editor & Website Manager; Chuck Baker – On-to-Int'l Convention Chair & Business Development Chair; Bob Parish – PAC Chair; Lowell Inkley – New Club Building-Utah Chair; Past Governors: Ralph Benson and Bill Mullins; and Bob Zimmerman – Member of Gem State, Boise; Wally Breitenstein – President Provo Golden K; and Phyllis Parish, Skip Flinders and others not named who came late (but early for the caucus to be held at 8am).

Janet presented the minutes of the third board meeting. Marvin moved; Bob Dempsay seconded to accept minutes; vote was unanimous. At the end of May membership for the District is down by 34 members. Governor Brent Ashworth stated the District is down by since 2007. As of June 20<sup>th</sup> the Kiwanis Int'l Foundation Annual Club Gift Campaign was going well, but needs the following clubs in the District to donate: Div 1 – Orem, Pleasant Grove and Price; Div 2 – Clearfield; Div 3 – Brigham City, Preston and Wasatch-Roy/Riverdale; Div 4 – Bannock-Pocatello and Idaho Falls; Div 5 – Buhl, Burley and Hailey/Wood River Valley; Div 7 – Cedar City and Santa Clara; Div 8 – Midvale/Fort Union and Sugar House; Div 9 – Nampa, New Plymouth, Payette and Ontario; Div 10 – Payson and Springville. Thus far the Utah-Idaho District has donated \$5.59 per member, but has a goal to be at \$6.00 per member by District Convention August 27-29, 2010. Thanks to those clubs who have donated \$6.00 per member or more. A special thanks to the Ogden Kiwanis Club for donating \$68.39 per member.

Marvin presented the Treasurer's Reports. Bob Dempsay moved and Gene 2<sup>nd</sup> with the vote being unanimous. The District is looking better because the investments have picked up. The District Foundation also has investments looking better.

The clubs who have donated to the District Foundation are: Div 1 – None; Div 2 – South Salt Lake Valley, Tooele; Div 3 – Logan; Div 4 – Pocatello, Rexburg, Shelley; Div 5 – Filer, Jerome, Rupert, Twin Falls; Div 6 – Capital City-Boise, Gem State-Boise; Div 7 – None; Div 8 – Heber Valley, Midvale/Fort Union, Park City, Sugarhouse; Div 9 – Emmett; and Div 10 – Provo, Spanish Fork. Kiwanis International provides MATCHING SCHOLARSHIPS and the District must provide the same amount. Last year \$6,000 was provided by Int'l and we are working toward that same amount this year. So far along \$4,719 has been donated to the District Foundation.

When the Blackfoot Kiwanis Club closed its doors the remaining monies were sent to the District. In the past these monies would have gone to the District Foundation. 

DONALD H. SMITH

1918 ~ 2010



Donald H. Smith, 92, died June 10, 2010, at his home in Provo, Utah. He was born in Ogden, Utah on February 15, 1918, to Mary McKenzie and Edward E. Smith. His early years were divided between Ogden and southern Idaho. He graduated from Ogden High School, Weber College and Brigham Young University. He worked for the USDA Soil Conservation Service, then enlisted

in the Army Air Corps and flew 35 combat missions as a B-17 bomber pilot. He attended graduate school at Iowa State College, and received his PhD degree in Soil Microbiology in 1951. He was employed by the USDA Agricultural Research Service as Soil Scientist, then for 10 years by Pineapple Research Institute, Honolulu, Hawaii, as Soil Chemist. In 1963 he became Agricultural Research Director and Research Manager for Del Monte's operations on Mindanao in the Philippines. In 1973 he returned from abroad and served as a research manager for Del Monte in California until his retirement in 1983.

In his younger years he was active in scouting, attained the Eagle rank, and later served as Scoutmaster and Explorer Advisor. He became a member of the LDS Church as a young adult and worked in several clerical and leadership positions.

dresses, financing our missions and being a faithful correspondent to each of us, writing weekly after we left home? Her magic letters helped us through our hard times.

Jean Hulme Tippetts Smith was born in Bloomington, Idaho, the only daughter of Ben and Louise Krogue Hulme. She was sandwiched between two older brothers, Harold and David and three younger brothers, Russell, John and Paul. She lived in the following cities, all located on Highway 89: Bloomington, Logan, Panguitch, Paris, Manti, Ephraim, Orem, Salt Lake, and Provo. She lived for 33 years in California.

Jean graduated from Manti High and Snow College. At Snow, she was the first female student body president and valedictorian, earning her tuition by playing piano accompaniment for the college orchestra. While teaching at Manti High, she met her husband Joyce Tippetts, a recently discharged naval officer from Ephraim who was the son of one of her favorite professors at Snow College. They both played in Lenny Myer's dance orchestra"he on bass fiddle and she as pianist. They were married on September 3, 1946.
