

Limited Membership Guidelines

Scope

This document shall serve as a guideline to determination of Limited Memberships in the Norfolk Noon Kiwanis.

Background

As a club, Norfolk Noon Kiwanis has established that all members shall be billed for all meals regardless of attendance. This policy has been well received for a number of years and the policy is in place and remains in place for all members in good standing. Within the past several years, some exceptions were made to that policy for Members who are otherwise in good standing but whose career makes it impossible for them to attend many meetings on Monday and therefore they would like to be billed only for those meals on days which they do attend.

Grandfather Clause

This updated policy does not affect any person who was granted Limited Membership by the board prior to this update being adopted.

New Guidelines

1. No person shall join the club from the outside as a Limited Member.
2. Limited Membership shall only be considered for Club Members who had otherwise been in good standing in the club for a period of 2 years.
3. Good standing, for the purposes of Limited Membership Consideration include the following:
 - a. Attendance of 25% of Monday Meetings in the past year.
 - b. Participation in at least 75% of Peanut Sales or Peanut Sales Follow-up Team.(i.e. Member with 4 years-service must have participated in 3 years of Peanut Sales)
 - c. Participation in at least 2 other Club Activities within the past 2 years (other activities include Kids Shopping, Kiwanis One Day, Mercy Meals Packing, Track Meet, etc.)
4. Limited Membership will require the completion of the Limited Membership application for clear determination by the Board. This will require an annual review with re-application by August 1 each year.
5. Limited Membership shall require outside documentation that confirms/explains the inability of this person to regularly attend Monday Meetings.
6. Limited Members under these new guidelines are still obligated to participate in the following or their status as Limited Member shall be revoked and full Membership billing will occur in the next billing cycle.
 - a. Participation in Peanut Sales/Peanut Sales Follow Up Team is Mandatory
 - b. Limited Members must participate in at least one additional activity per year.
 - c. Limited Members must attend at least three other Meetings per year (can include picnic or Royalty Night).
