RULES AND SCHEDULE OF EVENTS

The competition will consist of three divisions. The Divisions will be judged in two categories: Classical and Contemporary. The division of categories may be adjusted based on the number and type of entries' received. Division grades may vary according to the number of entries in each category.

***SENIOR DIVISION QUALIFICATIONS:** (To compete in Division)

1. 9th through 12th grade
2. Must not be above the 12th grade.
3. Must be amateur as per Kiwanis' guidelines.
4. Act cannot include more than five individuals, including accompanist.
5. Each act will be allowed five minutes. If more than seven minutes, act will be disqualified.
6. The show committee may disqualify any act for any reason it may deem proper.
7. An act of contestant may appear only once during the local Stars of Tomorrow Show.

***JUNIOR DIVISION QUALIFICATIONS** (Local competition only)

1. 6th through 8th grade.
2. If any one member is above the 9th grade. the group must compete in the Senior Division.
3. Same rules as 3 through 7 under the senior division.

***ELEMENTARY DIVISION QUALIFICATIONS:** (Local competition only)

1. Pre-Kindergarten through 2nd grade and 3rd through 5th grades. (2 categories)
2. If any one member of group is above the 5th grade. the group must compete in the division that member would be in.
3. Same rules as 3 through 7 under the senior division.
