Kiwaniis Foundation of Indianapolis, Inc. External Community Grant Guidelines

The Kiwanis Foundation of Indianapolis provides annual grants in the amount of up to \$2,500 for programs that serve children and youth in the City of Indianapolis that are designed to improve the quality of life directly through activities promoting health, education, etc. and through programs that encourage leadership and service among youth.

The Foundation will fund projects that:

- are consistent with the above stated purpose
- are considered start-up or seed money funding
- serve and impact the children and youth of the Indianapolis area.

The Foundation will not fund:

- programs that exclude participation on the basis of race, religion or sexual orientation
- operating expenses
- capital campaigns
- debt reduction
- individuals
- expenses that have already been incurred
- programs with religious purposes (This does not preclude religious organizations from applying for funds for non-religious service and leadership programs.)
- indirect expenses for a project
- multi-year funding

Who May Apply

- Submitting organization must be a 501 © (3) not-for-profit organization with an IRS qualifying letter
- Organization must serve the Indianapolis area

Other Restrictions or Requirements

- Groups and organizations may apply only once within the same calendar year.
- Groups and organizations can reapply for program funding on an annual basis but in no case shall funding exceed three years for the same program.
- Approved grantees must file a final report on the program within one month of the grant end date and agree to present the grant impact and results at a Kiwanis Club meeting to be mutually agreed upon.
